The Governor in Council in accordance with the powers conferred by section 48 of the Misuse of Drugs Law, 1997 makes the following order-

1. This Order may be cited as the Misuse of Drugs (Drug Trafficking Offences) (Designated Countries) (Amendment) Order, 1998.

Citation

2. Paragraph 2 of the Misuse of Drugs (Drug Trafficking Offences) (Designated Countries) Order, 1991 is amended by repealing the definition “appropriate authority of a designated country” and substituting the following-

Amendment of paragraph 2 of the Misuse of Drugs (Drug Trafficking Offences) (Designated Countries) Order, 1991

“appropriate authority of a designated country” means an authority of each of the countries specified in the First Schedule designated in accordance with paragraph 8 of Article 7 of the 1988 United Nations Convention Against Illicit Traffic In Narcotic Drugs And Psychotropic Substances;”.

3. The First Schedule of the Misuse of Drugs (Drug Trafficking Offences) (Designated Countries) Order, 1991 is repealed and the following is substituted-
