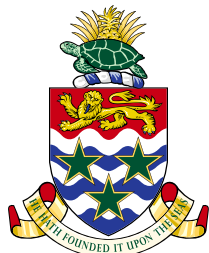

In exercise of the powers conferred by section 48 of the Exempted Limited Partnership Act (2021 Revision), the Cabinet makes the following Regulations —

Citation and commencement

1. (1) These Regulations may be cited as the Exempted Limited Partnership (Amendment) (No. 3) Regulations, 2024.
(2) These Regulations come into force immediately after the *Exempted Limited Partnership (Amendment and Validation) Act, 2024* comes into force.

Repeal and substitution of regulation 5 of the Exempted Limited Partnership Regulations (2021 Revision) - administrative fees

2. The *Exempted Limited Partnership Regulations (2021 Revision)*, in these Regulations referred to as the “principal Regulations”, are amended by repealing regulation 5 and substituting the following regulations —

“Fees for administrative services

5. For the purposes of sections 12A and 13 of the Act, the prescribed fee set out in the third column of the table in Schedule 4 is payable in respect of the corresponding administrative service set out in the second column of that table.



Express fees

5A. For the purposes of section 13 of the Act, the prescribed express fee set out in the third column of the table in Schedule 4A is payable in respect of the corresponding transaction set out in the second column of that table.”.

Amendment of Schedule 1 - fees

- 3.** The principal Regulations are amended in Schedule 1 by inserting after item 8 the following items and their corresponding particulars —
